### 1 Exchange admin center (EAC) - Data Source Configuration

#### **Prerequisites**

- The Exterro FTKC application has to be installed in the same domain where the Exchange server (on-premises) is installed.
- The service account has to be provided with the below permission and role type from the Exchange admin center.

Permission	Role type
Compliance Management	Mailbox Import Export

Add Exchange Trusted Subsystem group to the shared folders with read and write permissions.

**Note:** The shared folders should be accessible by the **Exchange** server.

- The Basic authentication type should be enabled for PowerShell using the below steps:
  - Create a new policy to enable the Basic authentication for PowerShell using the below command:
    New-AuthenticationPolicy "Allow only BasicAuth PowerShell" -AllowBasicAuthPowerShell

To enable the Basic authentication for a specific user, using the below command:

Set-User -Identity <UPN\_Service\_Acc> -AuthenticationPolicy "Allow only BasicAuth PowerShell"

**Note:** If required, you can disable all basic authentication using the below command:

Set-OrganizationConfig -DefaultAuthenticationPolicy "Disable all BasicAuth"




• The case result path should be a network shared path (accessible to Exchange Admin PowerShell and ADGWebLab self-host service users) without any drive characters (e.g., c\$, E\$).

### **Data Source Configuration**

- 1. Login to Exterro FTK Central.
- 2. From Home page navigate to **Exchange** data source.
- 3. In the Version field, select the Exchange Server EAC option.
- 4. Provide the **Name** of the data source.
- 5. Provide the Address (URL) of the Exchange Server EAC.
- 6. Provide the **Username**.
- 7. Provide the Password for the address.
- 8. In the **Confirm Password** field re-enter the configured password.

**Note:** Enable the **Associated to all custodian** checkbox to associate all the available custodians.

9. Click Save.



**Note:** You are recommended to select the newly introduced 'EAC' option against the 'Connector Type' field for performing the collection.



#### **Filters**

Only the following filters are applicable for Exchange Server EAC:

Filter	Description
Sender's Email	Provide the senders' email address.
Recipient's Email	Provide the recipients' email address.
Bcc's Email	Provide the 'Bcc' recipients' email address.
Cc's Email	Provide the 'Cc' recipients' email address.
Keyword(s)	Searches the keyword in email subject, sender, recipients and in the email body.
Subject	Searches with the provided email subject.
Creation Date	Message date option with Date Equals and Date Between options.

#### Limitations

- The 'Report Only' collection is not applicable for Exchange Server EAC.
- The 'Results Report' is not applicable for Exchange Server EAC. When the user tries downloading it, the 'Results Report download Failed' error message will be displayed.
- The 'Enable Recurrence' and 'Incremental Collection' options in 'Execution Mode' of collection configuration is not applicable for Exchange Server EAC.
- The 'Exclude' option in the 'Apply Filter' pop-up of 'Filters' will not be available for Exchange Server EAC.
- The 'Hits' column and 'Last File Collected' field in the 'Collection Progress' pop-up will display 'N/A' for the collections of Exchange Server EAC.
